This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You.

We use Your Personal Data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy.

Interpretations and Definitions

Interpretations

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this Privacy Policy:

Account means a unique account created for You to access our Service or parts of our Service.

Company (referred to as either “the Company”, “We”, “Us” or “Our” in this Agreement) refers to **Pacific Tax Solutions LLC**.

Cookies are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.

Country refers to: United States of America.

Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.

Personal Data is any information that relates to an identified or identifiable individual.

Service refers to the Website.

Service Provider means any natural or legal person who processes the data on behalf of the Company.

Usage Data refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself.

Personal Data

Types of Cookies We Use

Necessary / Essential Cookies

Type: Session Cookies

Purpose: Required for basic website functionality and security.

Cookies Policy / Notice Acceptance Cookies

Type: Persistent Cookies

Purpose: Stores cookie consent preferences.

Functionality Cookies

Type: Persistent Cookies

Purpose: Remembers user preferences such as language or region.

You may refuse cookies through your browser settings; however, some parts of the Service may not function properly.

Use of Your Personal Data

The Company may use Personal Data for the following purposes:

- To provide and maintain the Service
- To manage Your requests and inquiries
- To contact You via email, phone calls, SMS, or other electronic communication
- To provide information about services, updates, and events
- To analyze usage and improve our Service
- For legal, compliance, and security purposes
- For business transfers such as mergers or acquisitions

SMS Data Use and Disclosure

Business Transactions

If the Company is involved in a merger, acquisition, or asset sale, Your Personal Data may be transferred.

Law Enforcement

We may disclose Personal Data when required by law or in response to valid government requests.

Security of Your Personal Data

We use commercially reasonable measures to protect Your Personal Data; however, no method of transmission or storage is 100% secure.

GDPR Privacy

If You are located in the European Economic Area (EEA), You have rights including access, correction, deletion, objection, portability, and withdrawal of consent. You may exercise these rights by contacting Us.

CCPA / California Privacy Rights

If You are a California resident, You have rights under the California Consumer Privacy Act (CCPA), including the right to access, delete, and opt out of the sale of Personal Data. We do not knowingly sell Personal Data.

Children's Privacy

Our Service does not address anyone under the age of 13. We do not knowingly collect Personal Data from children under 13.
